#### **Product Description:**

Enduro Water Base Lacquer is an economical, high performing clear finish that provides superior clarity and hardness. Designed for interior use on furniture, cabinets, & millwork, it exhibits excellent water and chemical resistance. Enduro Water Base Lacquer dries rapidly and displays excellent early block resistance. It has illustrated superior performance to solvent based lacquers, providing improved stack times, hardness, lacquer thinner resistance, and fingernail polish remover resistance.

Enduro Water Base Lacquer is VOC-compliant, low odor, non-flammable, and will clean-up with soap and water. It is self sealing, however General Finishes Enduro Sanding Sealer is recommended to provide the optimum quality finish. Enduro Crosslinker can be added for additional chemical & water resistance.

## **Application:**

HVLP, air-assisted airless, or airless applications are recommended. HVLP: Use a 0.043" - 0.051" (1.1—1.3 mm) nozzle / tip assembly & Medium Air Cap. Air-assisted airless or Airless: 0.009"—0.013" tip, 300—600 psi fluid pressure, 10—30 psi air pressure. Allow 30 minutes -2 hours dry before sanding (temperature / humidity dependent). Sand with 220 micron (320 grit) or finer (extra fine finishing pad) between coats. 1—2 coats recommended.

## **Mixing and Application:**

 Catalyst Ratio: None necessary. Up to 4% Enduro Crosslinker may be added if desired.

• Pot Life: Not Applicable

• Shelf Life: 1 year, minimum

• Reducer/Thinner: EF Extender (5 –10%)

 Faster dry times may be achieved with the addition of 5—10% Enduro Accelerator

#### Stain & Sealer Recommendation:

For best results and superior adhesion, use General Finishes EF water base stain, General Finishes Industrial stain, or General Finishes Dye Stain. Oil base stains may also be used, however allow a minimum of 24 hours—72 hours dry before topcoating with Enduro Water Base Lacquer to assure that the oil base stain is thoroughly dry.

Enduro Water Base Lacquer is self sealing. However Enduro Sanding Sealer or Pre-Cat Sanding Sealer is recommended for optimum performance and appearance. Always adequately check adhesion to assure proper performance.

## **Surface Preparation:**

Surface must be clean, dry, and free of all contaminants. Sand raw wood with 150 grit before staining & topcoating. Sand between coats with 220 micron (extra fine pad) to assure proper appearance & adhesion.
